#### DEFINITIONS:

- 2.1 The Law Children (Education and Care Services National Law Application) Act 2010
   An Act to apply as a law of this State a national law relating to the regulation of education and care services for children
- 2.2 The Regulation Education and Care Services National Regulation under the Education and Care Services National Law
- 2.3 The National Quality Framework (NQF) This is the national education and care services quality framework. In legal terms, it refers to the Education and Care Services National Law, the Education and Care Services National Regulations including the National Quality Standard, and the prescribed rating system
- 2.4 National Quality Standard (NQS) A standard for education and care services designed to ensure the safety, health and wellbeing of children attending education and care service as well as improving their educational and development outcomes. The NQS comprises guiding principles, quality areas, standards and elements
- 2.5 Quality Improvement Plan (QIP) this is a process services and professionals will use to self assess, reflect on their practices in providing quality education and care, recognise their strengths and identify areas for improvement
- 2.6 Provider the person or entity who holds a provider approval, which allows the person or entity to operate an education and care service—this is Child Care Services Taree & Districts Inc
- 2.7 Learning Framework This is the Australian governments Early Years Learning Framework for early childhood educators (EYLF), and the Framework for school age children My Time, Our Place.
- 2.8 Education and care service means any service providing or intended to provide education and care on a regular basis to children under 13 years of age. Education and care premises in relation to Family Day Care is -
  - (i) an office of the family day care service; or
  - (ii) an approved family day care venue; or

(iii) each part of a residence used to provide education and care to children as part of the family day care service or used to provide access to the part of the residence used to provide that education and care

- 2.9 Family Day Care Educator A person who is engaged by or registered with a family day care service to provide education and care to children in a residence or an approved family day care venue
- 2.10 Nominated Supervisor a person who holds a supervisor certificate and has been nominated by the approved provider of an education and care service to be the nominated supervisor of that service, and has consented to that nomination in writing

#### **Definitions continued:**

- 2.11 Certified Supervisor a person who holds a supervisor certificate
- 2.12 Department of Education and Communities (DEC) It is the 'state regulatory authority' in NSW. The department will assess services under the National Quality Framework and is responsible for ensuring compliance under the Regulation.
- 2.13 Department Education Employment and Workplace Relations (DEEWR) this is the department representing THE COMMONWEALTH OF AUSTRALIA (Commonwealth) that the service is bound by annual agreement to operate the service. The service receives funding under the

Community Support Program from DEEWR to assist with costs to sustain the service

- 2.14 Australian Children's Education and Care Quality Authority (ACECQA pronounced A/SEE/KWA) This is the national body set up to guide the administration of the NQS to ensure consistency in its implementation across Australia. It will also promote and foster continuous quality improvement by services, publish, monitor and review ratings and assess and determine applications for the highest level of rating
- 2.15 Service Structure this is the service structure of Child Care Services Taree & Districts Inc. The service is a community based not for profit organisation and is managed by an elected committee. The rules which govern the organisation are set out in the organisation constitution. The committee are responsible for the operations of the service however they employ staff to operate the day to day operation of the service.
- 2.16 Regulatory authority the Director-General of the NSW Early Childhood Education and Care Directorate is the regulatory authority in NSW, responsible for assessing and rating services and ensuring their compliance with requirements
